- Call to Order by Mayor Hoopes at 7:02 Pm
- Pledge of allegiance- led by Mayor

Roll call by City Clerk. In attendance is Mayor Hoopes by phone, Tom Abbott, Aaron Hansen, Brent Schindler and Blaine Ball. Also in attendance is City Attorney Bart Birch, Bryce Klingler, Carol Lenz, Paige Lemieux, Clinton Lemieux and Bob Hansen.

Action Items-

Lift Emergency Declaration – Action

Discussion followed on whether City of Tetonia was ready to lift the Emergency Declaration that was set in place for COVID-19. It was discussed that it would remain in place until further notice. No motion needed.

Approval of Teton County emergency operations plan – Action

An emailed Teton County and Cities, Emergency Operations Plan was discussed. This plan hasn't been updated in 5 years. Schindler would like to ask Teton County in the future for a redline draft so we would know what changes from year to year. Schindler moves to approve, Abbott seconds. Motion passed.

Reschedule Dutch Oven Cook-Off -Action

Annual Dutch Oven Cook off will be rescheduled. Abbot moves to postpone Dutch Oven Cook Off until a later date this fall, Schindler seconds. Motion Passed.

July 4th Activities-Action

Clerk Beard updated Council about people asking for Tetonia to hold a fourth of July celebration. Activities requested would be 5K, Parade and Vendor Fair. Mayor Hoopes addressed the lack of volunteers for that day being a holiday, as well as finances. Clerk Beard brought up options and what the top costs would be for holding a large event. Parade route could be spaced to allow people to stay in cars if they would like. 5K could be held on the Rails to Trails and people could be sent out in waves to control grouping. Vendor fair could be spaced out throughout the park to avoid clustering of people. The State of Idaho has been put into stage 4, opening up group gatherings. Schindler moves to proceed with 4th of July celebrations including a 5K, Parade and Vendor Fair, Ball seconds. Motion Passed

Parking signage- Action

Discussion of parking signage were discussed. Certain places on Main Street have problem areas for parking and maintenance for City workers. Options of overnight limitations were discussed. Also, the pocket park pull out has been having people parking for long spaces of time. Pocket Park will have a 2 hour parking sign made for the pull in area. Idaho Transportation Department has agreed to help with signage along Main Street if the City has an ordinance to back it up, which the City has. Ball moves to postpone the highway signs and move forward on pocket park parking limitations. Schindler seconds. Motion passed.

Tetonia Library Updates-Action

Carol Lenz, Member of the Tetonia Library Committee, asked the City Council if the library could include an insert into monthly utility bills asking for 1 time donations from Tetonia Resident. Options of other donations were discussed. No motion needed.

Road Mag for Perry Avenue-Action

Public Works is requesting MAG dust control in front of the City Shop. Cost and coverage areas were discussed. Ball recommended doing a swap with Teton County for MAG for a swap on labor. LTHAC Grants were also discussed for options.

Schindler moves to reorder the agenda to move discussion before the consent agenda, Hansen seconds. Motion passes.

- <u>Bob Hansen Business License Updates</u> Hansen discussed the need for business licensing within the City. He wanted to make sure every business in the City was going to be required to register.
- <u>FY 2021 Budget planning</u> Budgeting will continue at the next work session.
- <u>COVID-19 updates</u> No COVID-19 updates at this time.

<u>May 2020 minutes-</u> Hansen moves to approve May 2020 minutes with spelling and grammar corrections. Schindler seconds. Motion passed.

May 2020 Claims- Schindler moves to approve claims as proposed. Ball seconds. Motion passed.

May past due accounts- Past due accounts discussed.

<u>Staff Reports</u>- Included in packets. Staff reports were discussed and clarified.

Executive session to discuss personnel per Idaho Code 74-206A – Action

Hansen moves to go into executive session. Schindler seconds. Motion Passed. By roll call vote: Hansen- Yes, Abbott- Yes, Ball-Yes, and Schindler- Yes. Executive session begins.
